I refer to my previous letter in respect of the above appeal. The Planning Inspectorate in Bristol has now confirmed that the inquiry will start **10:00am on 8 December 2022.** The inquiry is anticipated to last **until Wednesday 21 December 2022** and will be held at **Buckinghamshire Council, King George V House, King George V Road, Amersham, HP6 5AW**.

The Inspector appointed to hold the inquiry will be S Wilkinson BA, BPI, Dip LA, MBA, MRTPI.

Members of the public may attend the inquiry and at the Inspector's discretion are able to speak. Please note that anyone wishing to speak must be present when the inquiry opens.

Using the Council's application reference, the planning application and appellant's grounds of appeal are available to view on the <u>Council's Public Access System</u>.
